SUBJECT: Report on member input 2017

Here is how the opportunity for members to contact the board, through the president were offered.

- Post as a standing item on the iafp.com home page, <a href="http://www.iafp.com/member-input">http://www.iafp.com/member-input</a>
- Send single subject blast email to all members once between each board meeting, Completed
- Build option into bi-annual member survey, Completed and input received
- Mention once each month in e-news, and in each quarterly Family Physician Completed

Members provided input in many ways, not only through the <u>president@iafp.com</u> email box. Appended below is a list of the members who submitted questions and the status of those comments, suggestions, or requests.

## Enacted at the Feb. 17, 2017 board meeting:

The president will author a descriptive paragraph encouraging participation and seeking members' ideas, questions and concerns. The input from members would come to the <a href="mailto:president@iafp.com">president@iafp.com</a> mailbox. The president will triage the incoming input to the following:

- Staff to handle an informational item or a transactional item
- Refer it to a committee for its consideration
- Refer it to the Executive Committee or board if that level of consideration is needed.

There will be a timeline for response back to the member, and to the staff/committee/board so that the expectations of the member are shaped to the level of response that will be necessary. Additionally, the board will be kept informed of all member input via a report to each board meeting. Here is the process envisioned from the member point of view:

- Send an email to the <u>president@iafp.com</u> address or complete an on-line form that is sent to president@iafp.com
- A "read receipt" or other acknowledgement would follow (establishing a trail of accountability)
- President, with staff's support, will assign the query to the staff/committee/board
- Member will be informed of status of their input
- At the next scheduled meeting of committee/board, the topic will be placed on the agenda with time for discussion and that member's input could be sought
- After completion of activity on the input, member will be notified of status

Here is the process for making members aware of the opportunity to provide input:

- Post as a standing item on the iafp.com home page
- Send single subject blast email to all members once between each board meeting
- Build option into bi-annual member survey
- Mention once each month in e-news, and in each quarterly Family Physician
